

### 2024 ANNUAL GENERAL MEETING OF SHAREHOLDERS

### NOTICE AND ACCESS NOTIFICATION TO SHAREHOLDERS

You are receiving this notification as Surge Copper Corp. (the "**Company**") has decided to use the notice and access model for delivery of meeting materials to its shareholders in respect of its 2024 Annual General Meeting ("**Meeting**") to be held on September 25, 2024. This Notice of Meeting is prepared under the notice and access rules that came into effect on February 11, 2013 under National Instrument 54-101 "*Communication with Beneficial Owners of Securities of a Reporting Issuer*". Under notice and access, shareholders still receive a form of proxy (the "**Proxy**") or voting instruction form enabling them to vote at the Meeting. However, instead of a paper copy of the Company's management information circular (the "**Information Circular**"), shareholders receive this notice with information on how they may access such materials electronically. The use of this alternative means of delivery is more environmentally responsible, as it will help reduce paper use and the Company's carbon footprint, and will also reduce the cost of printing and mailing of the Meeting materials to shareholders.

### **MEETING DATE AND LOCATION**

The Meeting will take place at 888-700 West Georgia Street, Vancouver, B.C. Registered shareholders and validly appointed proxyholders may attend the Meeting in person. Meeting participants are requested to read the notes in the enclosed form of proxy (the "Proxy") and then to complete, sign, and mail the enclosed form of proxy in accordance with the instructions set out in the proxy and in this circular. Shareholders who wish to vote at the Meeting will have to do so in-person.

## SHAREHOLDERS WILL BE ASKED TO CONSIDER AND/OR VOTE ON THE FOLLOWING MATTERS:

- 1. **FINANCIAL STATEMENTS**: To receive and consider the audited consolidated financial statements of the Company for the financial year ended March 31, 2024, together with the auditor's report thereon. NOTE: There are no financial statements included in the mailing. The audited consolidated financial statements and related Management's Discussion & Analysis have already been mailed to those shareholders who have previously requested to receive them. See the section entitled *"Particulars of Matters to be Acted upon 1. Financial Statements and Auditor's Report"* in the Information Circular.
- SET THE NUMBER OF DIRECTORS: To set the number of directors of the Company at seven (7). See the section entitled "*Particulars of Matters to be Acted upon 2. Set Number of Directors*" in the Information Circular.
- 3. **ELECTION OF DIRECTORS**: To elect directors of the Company for the ensuing year. See the section entitled "*Particulars of Matters to be Acted upon 3. Election of Directors*" in the Information Circular.

- 4. **RE-APPOINTMENT OF AUDITORS**: To re-appoint DeVisser Gray LLP, Chartered Professional Accountants, as auditors of the Company for the ensuing year and to authorize the directors of the Company to fix the auditors' remuneration. See "*Particulars of Matters to be Acted upon 4. Re-Appointment of Auditors*" in the Information Circular.
- 5. **APPROVAL OF SHARE COMPENSATION PLAN**: To consider, and if thought fit, to pass, with or without variation, an ordinary resolution, in the form included in the Information Circular, approving the Company's share compensation plan (the "**Share Compensation Plan**"). See "*Particulars of Matters to be Acted upon 5. Approval of Plan Resolution*" in the Information Circular.
- 6. **APPROVAL OF ISSUANCE OF COMMON SHARES TO EXECUTIVE MANAGMENT**: To consider and, if thought fit, to pass, with or without variation, an ordinary resolution of disinterested shareholders, in the form included in the Information Circular, approving the issuance of common shares to to settle executive management's 2023 annual discretionary compensation. See "Particulars of Matters to be Acted upon 6. Approval of Common Share Issuances to Executive Management" in the Information Circular.
